



## ATTENDEE BIOS

**Rep. Brian Best (R-Iowa)** is the vice chair of the Iowa House Transportation Committee. He also serves on the Economic Growth, Human Resources, Natural Resources, and Health & Human Services Budget Committees. He was first elected to the Iowa House in 2014.

**Rep. Judy Clibborn (D-Washington)** is the chair of the Washington House Transportation Committee. She also serves on the Health Care & Wellness Committee. She is in her 13th year in the legislature and her eighth year as Transportation Committee chair. She is a former co-chair of the CSG Transportation Public Policy Committee and currently serves as chair of the CSG West Transportation & Economic Development Committee.

**Rep. Andy Davis (R-Arkansas)** is serving his second term in the Arkansas House of Representatives. He is the vice chair of the Rules Committee, the committee for Agriculture, Forestry and Economic Development, and the committee for Revenue and Taxation. He also serves on the Legislative Joint Auditing Committee. He previously served on the House Public Transportation Committee.

**Sen. Fred Girod (R-Oregon)** chairs the Oregon Senate Rules Committee. He also serves on the Revenue Committee. He was appointed to the Senate in 2008 after previously serving non-consecutive terms in the Oregon House.

**Rep. Carl Glimm (R-Montana)** serves as vice chair of the Interim Joint Committee on Water Policy. He has served in the Montana House since 2013.

**Sen. Scott Hammond (R-Nevada)** is co-majority whip in the Nevada Senate. During the 2015 legislative session, he served as chair of the Transportation Committee and vice chair of the Education Committee. He currently serves as vice chair of the CSG West Transportation & Economic Development Committee. He was first elected in 2012.

**Rep. Isaac Latterell (R-South Dakota)** is a member of the South Dakota House Judiciary and Taxation committees. He was first elected in 2012.

**Rep. Armando "Mando" Martinez (D-Texas)** is the vice chair of the House Transportation Committee in the Texas House of Representatives. He also serves on the Transportation Planning, Higher Education and Federal Environmental Regulation committees. He was first elected in 2004.
